CONTRACT TERMS AND CONDITIONS FOR MEMBERSHIP

Please read this document thoroughly to prevent any misunderstanding

1. Fees are payable in cash or per cheque, bank deposit or electronic transfer. Cheques can be made out to **TINCO Water Activity Center** as a cash cheque or crossed cheque. Fees are payable when attending the FIRST lesson of each month. As regards fees paid later than the 7th (seventh) of each month, a levy of R30.00 will be charged for each week until the arrear fees have been paid in full.

Please send your proof of payment to the swimming school so that your account can be credited. Proof of payment can also be faxed or e-mailed. Please use the learner's client name as stated on the Registration Confirmation as reference when an electronic transfer or deposit is made. **Fax :** 088 012 333 4597. **E-mail :** info@tincoswimschool.co.za
3. Fees and proof of payment can be put into the payment envelope and placed in the Tinco Postbox at the swimming area. Tinco Water Activity Center will not accept responsibility for payment made via a third party which may then get lost.
4. All cost in connection with R/D cheques or non-payment of fees will remain the responsibility of the person responsible for the payment of such fees.
5. The parent / guardian will be responsible for the payment of all costs and / or legal cost which may arise from any action taken by Tinco Water Activity Center to collect arrear fees.
6. When a payment is made, it is accepted that the terms and conditions of Tinco Water Activity Center as contained in this document, are accepted by the parent / guardian.
7. **TERMINATION OF LESSONS:** Membership will continue for an indefinite period until one calendar month written notice has been received, or one month's fees have been paid to the swimming school in lieu of the notice month. **NOTICE MAY NOT BE GIVEN BETWEEN 31 OCTOBER AND 31 JANUARY.** All notices must be delivered by hand or must be sent to Tinco Water Activity Center by registered post no later than the first day of the learner's last month of swimming instruction. No telephonic or verbal notice will be accepted.
8. The fees are payable **IN FULL** throughout the year except during **June and July** when you will have the option of putting the lessons temporarily on hold and presume the lessons beginning of August. This holding fee will be equal to the value of 50% of the normal fee for June and July except when lessons continue as normal throughout this period.
9. **DURING DECEMBER AND JANUARY THE MONTHLY FEES MUST BE PAID IN FULL TO COVER THE SWIMMING SCHOOL'S EXPENCES.** Lessons missed during this period can be made up through additional lessons at the learner's request.
10. Lessons are given on an ongoing basis throughout the year. The school will however be closed on Sundays and public holidays. The swimming school will also be closed during school holidays but will continue to give lessons on request as agreed between Tinco Water Activity Center and the learner.
11. Allowable swimwear for learners is swimming-pant / a swimming costume. No bikinis and baggy shorts are allowed. Learners must provide their own towels. Learners with **long hair** MUST wear a swimming-cap. A learner who does not have a cap will be provided with one and the cost will be charged to the fees at the end of the month.
12. No **PARENTS** or any other persons are **ALLOWED** in the swimming-pool area during lessons. Parents may however watch through the window from outside.
13. Lessons missed, cancelled or not attended, will **not** be made up. Lessons missed as a result of public holidays will not be made up.
14. Children may not move around the swimming pool or get into the swimming pool before or after the lesson without the instructor's permission.
15. Only learners who are getting dressed or are having a lesson are allowed in the swimming-pool area.
16. Learners must blow their noses and visit the toilet before they start with a lesson.
17. Please leave the toilets as you found them. Children under the age of 5 years must visit the toilet under supervision.
18. Learners are not allowed to play in the dressing rooms.
19. If a learner disrupts a class, he / she will be given a warning, and should this type of behaviour persist, he / she may be requested to leave the class.
20. Tinco Water Activity Center will not be held responsible for the loss of any possessions or property belonging to learners or any person who enters the premises of Ben Swart Street 1204 Môregloed.
